


Pertamina Investor Day 2023 is an event hosted by Pertamina that aims to provide investors with the company's insightful information. Started in 2013, this is the 9th time Pertamina Investor Day is being held. This year, for the first time after the pandemic, Pertamina Investor Day is conducted onsite in Pertamina's office for two days on 3-4 July 2023 with a more comprehensive concept including: Earnings Calls, Business Meetings and Project Teaser Updates, Small Group Investor Meetings, Engagement Dinner, and Site Visit to Pertamina Group Project/Operation Unit.

Furthermore, this event not only serves as a means for PT Pertamina (Persero) to communicate with the market, but it also allows investors and business partners to interact with Sub Holdings and Pertamina Subsidiaries.

There were 199 investors/partners participants from inside and outside Indonesia attending this event both online and onsite.

- Project Catalog: Publication of 26 projects to investors/partners that can be developed in the future.



At this event, 12 Subholdings and Subsidiaries participated in the showcase. With a simple and compact mini booth / exhibition format, investors and business partners can see Pertamina's entity profile directly, interact, and ask questions to the officers on site.
