


Subholding Gas Pertamina Maintains Performance of Gas Transporter for the Sumatra – Singapore Region and Support IKN



Senipah – Balikpapan Pipeline Project

Senipah — Balikpapan Pipeline Project (Senibal), aims to support the RU V Balikpapan Refinery Development Master Plan (RDMP) as a National Strategic Project and develop natural gas infrastructure in East Kalimantan. This strategic project is also a manifestation of Pertamina Group in supporting the development of the New State Capital (IKN) through the supply of natural gas for IKN.

In the East Kalimantan region, PGN manages gas distribution in an integrated manner including the Senipah-Balikpapan Transmission Pipeline (construction 2022-2023), Distribution of City Gas in Samarinda, Kutai Kartanegara, Bontang, and Balikpapan, LNG Filling Station Bontang, and development of LNG Retail to Industry and Commercial.



PT Perusahaan Gas Negara Tbk (PGN)

PT Perusahaan Gas Negara Tbk (PGN) is the largest company engaged in the transmission and distribution of natural gas in Indonesia. They have transformed into a gas subholding part of PT Pertamina (Persero) Oil and Gas Holding dedicated to one goal: Providing the expertise, energy and infrastructure needed to drive Indonesia's long-term economic growth. PGN (PGAS:IJ) is also the leading IDX listed natural gas distribution and transportation player in Indonesia and continues to strengthen its position in the market by gradually transforming into an integrated energy solution company, encouraging the use of natural gas.

PGAS become subsidiary of PT Pertamina (Persero) since 11 March 2018 as part of Government of Indonesia's Oil & Gas Holding initiatives. With the acquisition of 51% stake in PT Pertamina Gas (and its subsidiaries) on 28 December 2018, PGAS has officially been the Gas Sub-holding Company.
